Emissions reduction targets

To continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 52.63 tCO₂e by 2029. This is a reduction of 25%.

Carbon Reduction Projects

The following environmental management measures and projects have already been completed or implemented.

- Maintained ISO14001certification.
- Our office is heated via electricity, gas is not used.
- Rolled out hybrid vehicles in our fleet.
- Implemented a cloud-based project management software Abilo which has reduced paper usage.
- Implemented a "Take Back Scheme" with Crown Paints.
- Using local supply chains.

In the future we hope to implement further measures such as:

- Increase hybrid and electric vehicles within our fleet
- Replace printers with more efficient versions
- Implement an office generated waste separation and recycling project
- Replace lighting with more energy efficient options such as LED/PIR lighting controls
- Explore other "Take Back Schemes"
- Using low carbon materials on our projects where clients' specifications will allow
- Using FSC certified wood with a full chain of custody on our projects
- Implement a Single Use Plastics Policy
- Recommend water saving fixtures and fittings where not specified by clients
